ORDER:

In the G.O. 1st read above, Government have issued rules called "Andhra Pradesh Government Professional Institutions (Regulation of admissions into under graduate Medical & Dental Professional Courses) 2004 and amended subsequently.

2. In the reference 5th read above, the Director of Medical Education, A.P., Vijayawada has reported that as per Rule 9 (1) of rules issued in the G.O 1st read above, fees for MBBS students in Government Medical colleges are Rs 10,000/- per every year for five years and out of which Rs. 3000/- shall be deposited in the College Development Society and remaining will be credited in to state treasury by way of challan. Further, as per rule 9 (iii), the fee shall be reviewed once three years by the Government, however, no review was done in the last 18 years.

3. The Director of Medical Education has further reported that in the G.O 4th read above, the Government have issued orders for separate fee structures for the Government Medical Colleges permitted from 2023-24. As per these orders, fees for the Competent authority (General category) is Rs. 15,000/- per annum.

4. The Director of Medical Education has therefore requested the Government to enhance the fee in Government Medical Colleges (11 Medical colleges) on par with the Competent Authority (General category) in Government Medical Colleges permitted after 2023-24 i.e from Rs. 10,000/- to Rs. 15,000/- per every year in five years and the said entire amount shall be deposited to the respective College Development Society.

5. The Government after careful examination of the matter, have decided to enhance the fee from Rs.10,000/- to Rs.15,000/- in (11) existing Government Medical Colleges which were established prior to the Academic Year 2023-24 by amending the Rules "Andhra Pradesh Government Professional Institutions (Regulation of admissions into under Graduate Medical & Dental Professional Courses) 2004 and as amended subsequently.

6. Accordingly, the following notification shall be published in the next issue of Andhra Pradesh Gazette:

NOTIFICATION

In exercise of the powers conferred by sections (3) and (15) of the Andhra Pradesh Educational Institutions (Regulation of Admission and Prohibition of Capitation Fee) Act, 1983 (Andhra Pradesh Act No. 5 of 1983), the Governor of Andhra Pradesh hereby makes the following amendments to the Andhra Pradesh Government Professional Institutions (Regulation of Admissions into Undergraduate Medical and Dental Professional Courses) Rules, 2004 issued in G.O.Ms.No.183, HM&FW (E1) Department, dated.30.06.2004 and published in Rules Supplement to Part-I Extraordinary Issue of the Andhra Pradesh Gazette No. 23, dated the 2nd July, 2004 as subsequently amended.

AMENDMENT

In the said rules, in rule 9, for sub-rule (i) the following shall be substituted namely, -

“(i) Fee for Government Medical Colleges

The fee in (11) Government Medical Colleges which were established prior to the academic year 2023-24 shall be Rs.15,000/- (Rupees Fifteen Thousand only). The fee shall be paid every year for 4 1/2 (Four and half) years. The entire fee of Rs.15,000/- collected shall be deposited to the respective College Development Society.”
